YEARLY REPORT OF OPERATION FOR 2002

Medina City Council & Mayor Medina County Commissioners

The following is the yearly report of operations of the Court as required by Ohio Revised Code Sec. 1901.14.

The Court received new filings of 17,930 cases and terminated 17,975 cases.

This case load generated \$4,445,687.02 of disbursements. Driving under the influence of alcohol (O.M.V.I.) charges decreased to 746 in 2002 from 856 in 2001 and 840 in 2000.

Brunswick Mayor's Court, which is in our court's jurisdiction, had 3,915 traffic cases filed, 168 O.M.V.I. cases filed, and 981 criminal cases filed for a total of 5,064 cases. Two Hundred and fifty-one of these entered not guilty pleas and were transferred to Medina Municipal Court.

Among the significant events affecting the work of the Court during the calendar year of 2002 are the following:

NEED FOR NEW BUILDING AND SECOND MUNICIPAL JUDGE

The building for the Medina Municipal Court was completed in 1983 after a fire set by a disgruntled defendant destroyed the previous location. Judge Dale H. Chase has served as Judge since 1988. There is one judge elected to serve in this position.

The jurisdiction of the Medina Municipal Court includes the City of Brunswick, the City of Medina, Spencer and Chippewa Lake Villages, and the Townships of Brunswick Hills, Chatham, Granger, Hinckley, Lafayette, Litchfield, Liverpool, Medina, Montville, Spencer and York. The Medina County Planning Commission estimates the 2002 population of the Court's jurisdiction at 115,168.

The most recently available statistics from the Ohio Supreme Court (Ohio Courts Summary – 2001) indicate that the average caseload for each municipal judge in Ohio is 13,475. There are 21 municipal courts in Ohio served by two judges. These courts had an average population of 107,991, (53,996 per judge) and an average total caseload of 25,027, (approximately 12,514 cases per judge).

The existing facility, staff and number of judges is not adequate to meet the present and reasonably expected future needs of this jurisdiction. A second judge and a new facility are a necessity.

The position of a municipal judge is an elected position, which must be created by the Ohio General Assembly on the recommendation of the Ohio Supreme Court. This process can only proceed when we have committed as a community to construct an adequate facility to house a second judge plus the necessary staff to handle the caseload of the court.

One full-time and two part-time magistrates share one desk in one office. There are four bailiffs sharing two desks in two offices. On crowded mornings people sit on the floor in the small court lobby because there is not enough space for everyone who is required to attend court. There is not enough parking for the people who drive to court along with space for court staff.

There is no holding cell or secure location for prisoners. Prisoners are escorted through crowds in the lobby, through staff areas, and near the judge's office.

Attorneys must meet with their clients in the halls or outside the building because there are no private locations available.

Effective on January 1, 2001, the court created an additional court cost of \$10.00 per case, to help cover a portion of the cost of a new building. This means that part of the cost for this facility will be paid for by people convicted of criminal and traffic offenses and by participants in civil cases before the court. This cost generated \$161,362.20 in 2001. Judge Chase increased this to \$20.00 per case beginning January 1, 2002. In 2002 this cost generated \$300,773.50.

PROBATION DEPARTMENT

During the year, 709 people were placed on probation. 318 were for driving under the influence of alcohol (O.M.V.I.) convictions, 65 for drug convictions, 42 for domestic violence convictions, with an additional 43 disorderly conduct convictions which originated as domestic violence cases. 75 were for underage alcohol possession/consumption, and 14 were for operating a motor vehicle after underage alcohol consumption (O.M.V.U.A.C.). Thirty-three were for theft related offenses (the only category to increase from the previous year). Twelve were for assault and 11 were for menacing. The remaining 94 were an assortment of cases such as: obstructing official business, corruption of a minor, resisting arrest, carrying a concealed weapon, falsification, indecent exposure and child endangering.

510 pre-sentence interviews were completed. Over 900 additional abbreviated presentence reports were completed for underage alcohol, drug paraphernalia/drug abuse and first and second offense (within 6 years) O.M.V.I. cases. The pre-sentence officer contacted 177 victims to request a victim impact statement and completed twelve victim interviews.

The overall caseload averaged 952 for the year. Probation officers held over 3,400 individual reporting appointments. A total of 43 people participated in group reporting. Offenders on the caseload submitted to 1,135 drug screens. Seventy-one probationers completed 1,900 community service hours through the Medina County Volunteer Center. The majority of the caseload participated in alcohol or other substance abuse counseling as a condition of probation. One hundred eleven individuals served 6,112 days of electronically monitored home arrest through the Medina County Sheriff's department, as coordinated by the probation department.

Probation violations were filed against 153 individuals.

COMPUTER DEVELOPMENTS

The court employs a Management Information Specialist to coordinate all technology applications. The current equipment in place consists of 37 printers and 38 PC's. The RS6000 main server was joined this year by two additional IBM X series servers. The new servers handle the online court access and protect the system as a firewall. In 2002, the court completed a transition to all Dell computers. All systems were standardized to Office 2000 Professional Version, and the upgraded version of Norton Antivirus. The installed value of computers and software is approximately \$300,000.

Online access servers were installed in the 2nd quarter of 2002. This included upgrades to current court software and modifications to the web page for direct access to the court

records system. The current system allows online interrogation of court records using a standard internet connection and browser. This system updates continuously during the day. The court software was upgraded by the vendor to conform with federal, state and local laws.

The probation department began scanning historical records into the imaging database in the 4th quarter of 2002. This imaging database allows documents to be stored in digital format and printed on demand. This increases the efficiency of the department, prevents misplaced files, saves clerical time in retrieving the files, and reduces the space required for storing the information. Digital pictures are placed in each probationer's file for positive identification.

VIDEO ARRAIGNMENTS

Arraignments (initial appearances in criminal and traffic cases) are conducted by the magistrates. In 1997, the Court began conducting these proceedings via remote video link with the Medina County Jail. This continues to work well not only for security reasons but also saving police departments many person hours by not having to transport prisoners from the jail to the Court. The remote video process is less disruptive to other litigants and witnesses who are waiting to appear before the magistrate for other cases. Security at the courthouse is improved because unruly defendants remain in custody at the jail and pose no risk to court staff or the public.

Internet Site

In the past year, the court has added a number of features, including those listed below, to its Web site. All features are available at the Court's home page at www.medinamunicipalcourt.org.

The Fine Waiver Table is a complete list of all offenses that can be paid by waiver, and the fine amount for each offense. The Fine Waiver Table is located at www.medinamunicipalcourt.org/2002 FineWaiverTable.pdf

The Speed Fine Calculator permits users to enter the information from their traffic citation and have the program calculate the amount of the fine that is due. Its address is www.medinamunicipalcourt.org/speed calc.htm

We have also added access for online case inquiry for users who wish to inquire about cases that have been filed in the court. Certain items of information, such as Social Security numbers, are not available due to privacy concerns. Online users can view information about any case filed since 1987. Online access is available at http://206.183.7.90/cmiflash/court/index.html or through the Court's home page.

Since this feature was added to the Web site, site usage has increased dramatically. From an average of 338 hits per week before the inquiry access feature was added, the average jumped to 584 hits per week since the feature was added.

Magistrates

Chief Magistrate Charles T. Lawrie has been with the Medina Municipal Court since 1991.

In January 2002, Lorie K. Brobst joined the Medina Municipal Court as a part-time magistrate, replacing Magistrate Susan Figler. Magistrate Brobst was raised in Hinckley, Ohio. She received her undergraduate degree in Biochemistry from Case Western Reserve University in 1986. After receiving her law degree from Cleveland-Marshall College of Law, she became an attorney in 1994. From June of 1998 to July of 2002, she served as a part-time Magistrate in the Juvenile Division of Medina County Common Pleas Court. In 2002, Magistrate Brobst was President of the Medina County Bar Association. Since 1999 she has served as an At-Large Trustee of the Ohio Association of Magistrates, currently holding the executive committee position of Treasurer. She continues to be an instructor for the Judicial College of the Supreme Court of Ohio. She is an active member of the Hinckley Chamber of Commerce and is the Medina district coordinator for the Mock Trial Competition presented by the Ohio Center for Law Related Education. She maintains a private law practice in Medina.

Magistrate Brobst joins part-time Magistrate Linda Leggett, who began working at the Court in 2001. All the magistrates are active members of the Ohio Association of Magistrates.

JUDICIAL SEMINARS

Judges and Magistrates are required to attend continuing legal and judicial education programs, including programs on ethics and substance abuse. The programs listed are all coordinated through the Judicial College of the Supreme Court of Ohio.

FOREIGN LANGUAGE INTERPRETING SERVICE

In the past few years, we have seen an increase in the number of criminal and traffic cases involving defendants who either do not speak English, or who need assistance in their native language in order to understand the court proceedings. When we are aware of this in advance, we arrange to have an interpreter physically present in court to translate. However, we often become aware of this need when a defendant is arrested and brought immediately to court the same day, or the defendant appears the next morning via video from the Medina County Jail. For these situations, the court has contracted with Language Line Services of Monterey, California to provide language translation for short court proceedings (about 5 to 10 minutes).

The company's interpreters are available by telephone. These preliminary proceedings are conducted in the magistrate's courtroom. A speakerphone and video recording system are all that is necessary to make a complete record of the proceedings. For longer legal proceedings, such as motion hearings or trials, the court arranges for translation services through Monarca Language Services, a Medina business.

CLERK'S OFFICE

In 2002 the records for 2001 were audited. The Court had an excellent audit. Clerk of Courts Judy L. Schwartz continues to be active in both the Northeast Ohio Municipal Court Clerk's Association and in the Ohio Municipal Court Clerk's Association. The Ohio Association has also started a Clerk's certification program. In order to be certified each clerk must earn 50 points by attending educational programs, seminars etc. Judy received her certification at the Ohio Municipal Court Clerk's Association spring meeting in May, 2002.

The clerk's office had another very busy year training new personnel and implementing procedures as the laws continue to change. The majority of the clerks are being cross-trained so they can do several different positions in the clerk's office. There are 9 deputy clerks and 1 chief deputy clerk. We now have 4 deputy clerks, two of whom normally work traffic, who are completely trained to work Civil and Small Claims, and 5 clerks who are trained to work the traffic and criminal counter. The clerk's office is working diligently to finish microfilming the old cases that have been partially purged from the computer system so we can begin scanning all documents into the cases on the computer with the new scanning equipment that was purchased in 2001. In 2002 almost 30,000 cases were microfilmed and shredded.

CUSTODIAN

The court's full-time custodian has been a big asset this past year, shredding microfilmed files, shoveling snow, mowing grass and handling all of the property inventory, while continuing to maintain the interior and exterior of the building and grounds. The custodian

continues to order all his own supplies and help with deliveries to all areas of the building. The high volume of people coming through the building requires constant attention to maintain a clean facility.

COURT REPORTER

The Medina Municipal Court currently employs one court reporter who is responsible for maintaining a record of all proceedings held before the Judge. All proceedings are stenographically recorded by the Court Reporter and are recorded on paper as well as computer disk for storage and maintenance. There is also a log kept and maintained by the Court Reporter of all proceedings held before the Judge.

Proceedings in front of the Magistrate are recorded electronically via videotape and the Court Reporter is responsible for the maintenance of the videotape log and the filing of all videotape proceedings.

The Court Reporter is also responsible for producing transcripts, when requested, and the preparation and filing of transcripts on appeal.

The Court Reporter is an active member of the Ohio Court Reporters Association and the National Court Reporters Association which provides information and seminars on court reporting issues and education.

BAILIFF'S OFFICE

In 2002, the court employed Bailiff William Saus and three Deputy Bailiffs, Richard Leggett, Curt Bell and Carl Meding.

In 2002, the bailiff's office replaced the used 1996 Ford Crown Victoria bailiff's car with a new 2002 Chevrolet Impala from the official state-approved vendor.

On April 20, 2002, Deputy Bailiff Carl Meding was selected as "Court Officer of the Year" by the Ohio Bailiffs & Court Officers Association.

Bailiff Saus and Deputy Bailiffs Bell and Meding maintained their firearms qualifications as required by the Ohio Peace Officers Training Association.

Bailiff Saus continued to serve on the Ohio Judicial College's Personnel Education & Training Committee and as chairperson for the Training Committee for the Ohio Bailiffs and Court Officers Association.

At the end of December 2002, thirty-seven year veteran Deputy Bailiff Richard Leggett tendered his resignation to take effect in 2003.

Bailiff Carl Meding is also the Court's Warrant Officer. In 2002, he resolved 558 warrants, up about 10% from 2001. Five hundred forty-three were traffic or criminal warrants.

About 53% of the traffic and criminal warrants were issued because the defendant failed to appear (FTA) to pay fines and costs as ordered. Over 80% of the time, these fine and cost warrants are concluded by the defendant paying the entire amount that is owed to the court. Of the over \$101,000 that was due on these fine and cost warrant cases, the court collected almost \$81,000.

ALCOHOL TREATMENT FUND AND JAIL COSTS

In 2002 the Court collected \$20,604.60 in fines for the Indigent Drivers Alcohol Treatment Act. These fines can be used to pay for long term treatment of indigent defendants. The Court also collected \$39,630.50 for Driving Under the Influence of Alcohol Jail Costs, which was paid to the Medina County Auditor. The Court disbursed to Townships, Cities, and the State of Ohio a total of \$17,039.88 under the Driving Under the Influence of Alcohol Act, which arresting agencies can use for equipment, training and enforcement of driving under the influence of alcohol laws.

DOMESTIC VIOLENCE AND OTHER CRIMINAL CASES

In 2002 there were 148 domestic violence cases filed compared to 168 in 2001, 191 in 2000, 171 in 1999, 200 in 1998 and 251 in 1997.

The domestic violence law passed by The Ohio General Assembly effective December 9, 1994, established a State policy that the "preferred course of action" in a domestic violence incident is arrest and requires county, city, village and township law enforcement agencies to have written domestic violence policies and procedures for these cases.

Underage consumption of alcohol cases decreased to 162 in 2002 compared to 248 in 2001, 262 in 2000 and 114 cases in 1999. Drug paraphernalia cases decreased to 227 in 2002 compared to 393 in 2001 and 496 in 2000.

WEDDINGS

In 2002 the Judge performed 82 weddings compared to 102 weddings in 2001, 119 weddings in 2000 and 130 weddings in 1999.




