The following is the yearly report of operations for the Medina Municipal Court as required by Ohio Revised Code Sec. 1901.14.

The Court received new filings of 17,334 cases and terminated 17,302 cases.

These cases generated \$4,667,023.97 of disbursements, which include bond and civil judgments.

Driving under the influence of alcohol (D.U.I.), new and reactivated, cases increased 21% in 2004.

From 2001 through 2004 total cases filed by the Ohio State Patrol decreased by 23%. During that same time period cases filed by the Medina City Police Department decreased by 49%. Cases filed by all other agencies decreased by 1%.

During this 2001 – 2004 period, total new D.U.I. cases filed increased by 59%. Ohio State Patrol D.U.I. cases filed increased by 83%. Medina City Police Department D.U.I. cases filed decreased by 24%. D.U.I. cases filed by all other agencies increased by 71%.

NEED FOR NEW BUILDING AND SECOND MUNICIPAL JUDGE

The building for the Medina Municipal Court was completed in 1983 after a fire, set by a disgruntled defendant, destroyed the Court's previous location on the second floor above the former Open Pantry convenience store. Judge Dale H. Chase has served as judge since 1988. There is one judge elected to serve this court.

The jurisdiction of the Medina Municipal Court includes the cities of Brunswick and Medina, the villages of Chippewa Lake and Spencer, and the townships of Brunswick Hills, Chatham, Granger, Hinckley, Lafayette, Litchfield, Liverpool, Medina, Montville, Spencer, and York. The Medina County Planning Commission estimated the 2004 population of the Court's jurisdiction at 122,800.

The most recently available statistics from the Ohio Supreme Court (Ohio Courts Summary – 2003) provides caseload comparisons with other Ohio courts. There are 21 two-judge municipal courts in Ohio. These courts had an average population of 100,825 (50,412 per judge) and an average total caseload of 23,046 (11,523 cases per judge). There are 92 one-judge municipal courts in Ohio. These courts had an average population of 64,256 and an average caseload of 11,549.

On January 1, 2001, at the request of Medina City Council, Judge Chase assessed an additional court cost of \$10.00 per case, which was increased to \$20.00 on January 1, 2002, to help cover a portion of the cost of a new building. This means that most of the cost for this facility will be paid for by the people convicted of criminal and traffic offenses and by participants in civil cases before the Court. This cost generated \$296,825.07 from 2004 operations.

PROBATION DEPARTMENT

Marirose Power, Chief Probation Officer

The Probation Department employs three full-time general supervision probation officers, a full-time intensive supervision probation officer, a part-time officer supervising a specialized case load of drug offenders and some intensive supervision cases, a chief probation officer and two clerical staff.

The department completed 897 pre-sentence investigations and 1,201 abbreviated pre-sentence investigations on first and second offense D.U.I. cases for a total of 2,098 pre-sentence investigations. Over 2,500 traffic cases were reviewed prior to sentencing and 52 sealing-of-records investigations were completed.

Eight hundred thirty five new defendants were placed on probation. Sixty-two percent of these were for first, second, or third D.U.I. offenses. Nineteen percent were for underage alcohol consumption, 7% for drug offenses and 6% for domestic violence or a related offense. The remaining 6% were for an assortment of various criminal offenses, including

petty theft, criminal damaging, telecommunications harassment, vehicular homicide, and public indecency. The department collected \$10,462.56 in restitution for victims of crime. Over 4,100 reporting appointments were held and over 100 individuals were charged with probation violations.

For the third year in a row the Intensive Supervision Probation (ISP) program received a 100% rating on its annual performance from the State of Ohio Department of Rehabilitation. The grant-funded ISP program was expanded in 2004 to include a clinical case management component.

Indigent driver alcohol treatment account funds were used to increase monitoring of probationers. Eligible offenders were monitored by a dedicated clinician through Medina County's Alcohol and Drug Dependency Services, Inc. or by the previously mentioned clinical case manager who is affiliated with Alternative Paths Inc.

BAILIFF'S OFFICE

William Saus, Bailiff

In 2004, the Court employed a bailiff and four deputy bailiffs.

The bailiff's office handled daily operational tasks including court security, docket management, civil and criminal service of process, jury trials, enforcement of specific court orders and bench warrants. The bailiff's office maintains the Court's L.E.A.D.S. terminal for criminal justice purposes. The bailiff and deputy bailiffs successfully completed annual firearms qualification.

In 2004, the bailiff's office conducted warrant enforcement operations to follow up on cases where warrants had been issued for various contempt matters, including failure to pay fines and costs as ordered. This activity is reflected in the following warrant report:

COMPUTER DEVELOPMENTS

Rich Armstrong, Management Information Specialist

The court employs a Management Information Specialist to coordinate all technology applications. The current equipment in place consists of 40 printers and 43 PC's. An IBM RS6000 holds the court records, while two IBM X Series servers handle the online court access and protect the system as a firewall. All systems are standardized to Office 2000 Professional version and the Enterprise version of Norton Antivirus. The installed value of computers and software is approximately \$340,000, of which zero dollars came from the City of Medina general fund.

The department began the process of upgrading all Windows 98 SE PC's to Windows XP. This process continued throughout the year and will continue into 2005.

The department purchased equipment to upgrade the audio/visual capability of the Court. This was necessary since some of the arresting agencies are using DVD's to record traffic stops and the older system did not support the DVD technology. The new system will have the capability of displaying any DVD/CD format, or VHS tape format, in addition to information contained on personal computers. The system uses a projector to display the information on a large screen in the courtroom or a smaller portable screen if the system is to be used in another location. No City of Medina general fund dollars were used for this equipment.

Online court access was added to the Court's website in late 2002 and allows users to inquire about cases that have been filed in court. FOREIGN LANGUAGE INTERPRETING SERVICES

The Court continues to see an increase in the number of criminal and traffic cases involving defendants who do not speak English and require assistance in their native language to understand the court proceedings. The Court contracted with Language Line Services of Monterey, California to provide language translation for short court proceedings (approximately 5 to 10 minutes in length), and with Monarca Language Services, a Medina business, for all other translation services.

CLERK OF COURT

The records for 2003 were audited by the State Auditor's Office and the Court had an excellent audit.

Clerk of Court Judy L. Schwartz retired on December 31, 2004 after 22 years of service. Mrs. Schwartz was hired in May 1982 as the Chief Deputy Clerk and served as Clerk of Court since December 30, 1991.

The clerk's office employs one full-time chief deputy clerk and ten full-time deputy clerks. Cross training continued to be a major focus in 2004. It is the goal to have all clerks cross-trained and knowledgeable to serve the public, law enforcement agencies, attorneys, and the Court in all areas.

The clerks responsible for record retention microfilmed 26,692 case files and scanned 3,217 case files.

COURT REPORTER

The Medina Municipal Court currently employs one part-time court reporter who is responsible for maintaining a record of all proceedings held before the Judge. All proceedings are stenographically recorded by the court reporter on paper and computer disk for storage and maintenance. The court reporter maintains a log of all proceedings held before the Judge.

Proceedings in front of the Magistrates are recorded electronically and the court reporter is responsible for the maintenance of the Magistrate's log records of these proceedings.

ALCOHOL TREATMENT FUNDS AND JAIL COSTS

The Court collected \$25,369.50 in fines for the Indigent Drivers Alcohol Treatment Act (IDAT) in 2004. These fines can be used to pay for treatment of indigent defendants. The Court also collected \$56,542.00 for Driving Under the Influence of Alcohol jail costs, which was paid to the Medina County Auditor. The Court disbursed to townships, cities, and the State of Ohio a total of \$24,642.00 from fines collected under the Driving Under the Influence of Alcohol Act. These funds may be used by the arresting agencies for equipment, training, and enforcement of driving under the influence of alcohol laws.
