# **MEDINA MUNICIPAL COURT 2005 ANNUAL REPORT**

The following is the yearly report of operations for the Medina Municipal Court as required by Ohio Revised Code Sec. 1901.14.

The Court received new filings of 16,922 cases and terminated 16,734 cases.

These cases generated \$4,728,892.63 of disbursements, which include bond and civil judgments.

## **NEED FOR NEW BUILDING AND SECOND MUNICIPAL JUDGE**

The building for the Medina Municipal Court was completed in 1983 after a fire destroyed the Court's previous location on the second floor above the former Open Pantry convenience store. Judge Dale H. Chase has served as judge since 1988. There is one judge elected to serve this court.

The jurisdiction of the Medina Municipal Court includes the cities of Brunswick and Medina, the villages of Chippewa Lake and Spencer, and the townships of Brunswick Hills, Chatham, Granger, Hinckley, Lafayette, Litchfield, Liverpool, Medina, Montville, Spencer, and York. The Medina County Planning Commission estimated the 2004 population of the Court's jurisdiction at 118,041.

The most recently available statistics from the Ohio Supreme Court (Ohio Courts Summary – 2004) provides caseload comparisons with other Ohio courts. There are 20 two-judge general jurisdiction municipal courts in Ohio. These courts had an average population of 102,054 (51,027 per judge) and an average total caseload of 19,832 (9,916 cases per judge). There are 88 one-judge general jurisdiction municipal courts in Ohio. These courts had an average population of 45,057 and an average caseload of 10,071.

On January 1, 2001, at the request of Medina City Council, Judge Chase assessed an additional court cost of \$10.00 per case, which was increased to \$20.00 on January 1, 2002, to help cover a portion of the cost of a new building. This means that most of the cost for this facility will be paid for by the people convicted of criminal and traffic offenses and by participants in civil cases before the Court. This cost generated \$362,595.80 from 2005 operations.

### **PROBATION DEPARTMENT**

The Probation Department employs three full-time general supervision probation officers, a part-time officer supervising a specialized caseload of drug offenders and select intensive supervision cases, a full-time intensive supervision officer, a full-time chief probation officer, and three part-time clerical staff.

The department completed 774 pre-sentence investigations and 1,038 abbreviated pre-sentence investigations on first and second offense D.U.I. cases for a total of 1,812 pre-sentence investigations. Additionally, 58 sealing-of-records investigations were completed and 801 traffic cases were reviewed prior to sentencing.

Seven hundred ninety five new offenders were placed on probation. Of these, fifty-six percent were convicted of a D.U.I. offense. Eleven percent were for underage alcohol consumption and 10% were for domestic violence or a related offense. Six percent were drug offenses, three percent were traffic offenses, and an additional three percent were theft offenses. The remaining 11% were for various criminal charges such as assault, corruption of a minor, telephone harassment and obstructing official business.

The caseload averaged 790 throughout the year and slightly over 4,000 reporting appointments were held. Drug screens totaled 1,647 for the year. One hundred two individuals were formally charged with violating one or more conditions of probation.

## **ALCOHOL TREATMENT FUNDS AND JAIL COSTS**

The Court collected \$25,303 in fines for the Indigent Drivers Alcohol Treatment Act (IDATA) in 2005. These fines can be used to pay for treatment of indigent defendants. The Court also collected \$51,462.00 for Driving Under the Influence of Alcohol jail costs, which was paid to the Medina County Auditor. The Court disbursed to townships, cities, and the State of Ohio a total of \$24,282.62 from fines collected under the Driving Under the Influence of Alcohol Act. These funds may be used by the arresting agencies for equipment, training, and enforcement of driving under the influence of alcohol laws.

## **BAILIFF'S OFFICE**

In 2005, the Court employed a bailiff and four deputy bailiffs.

The bailiff's office handled daily operational tasks as prescribed in Section 1901.32 of the Ohio Revised Code. The bailiff's office assisted with court security issues, docket and courtroom management, civil and criminal service of process, jury trials, enforcement of specific court orders and bench warrants. The bailiff's office maintains the Court's L.E.A.D.S. terminal for criminal justice purposes. The bailiff and deputy bailiffs successfully completed annual firearms training, and continuing education seminars to enhance job skills.

In 2005, the bailiff's office helped launch the Court's Most Wanted program to help locate individuals that have outstanding warrants.

## **COMPUTER DEVELOPMENTS**

The court employs a Management Information Specialist to coordinate all technology applications. The current equipment in place consists of 40 printers and 43 PC's. An IBM RS6000 holds the court records, while two IBM X Series servers handle the online court access and protect the system as a firewall. All systems are standardized to Office 2000 Professional version and the Enterprise version of Norton Antivirus. The installed value of computers and software is approximately \$360,000, of which zero dollars came from the City of Medina general fund.

The probation department continued scanning historical records into the imaging database during 2005. This imaging database allows documents to be stored in digital format and printed on demand. This increases the efficiency of the department, prevents misplaced files, saves probation officer time in retrieving files, and reduces the space required to store files.

The technology department continued the process of upgrading all Windows 98 SE PC's to Windows XP. Approximately 35 PC's are involved in the upgrading process. The Court's website was upgraded in 2005 to allow the posting of the Most Wanted Posters.

The Management Information Specialist attended various meetings in 2005 concerning the new laws enacted by the Ohio Legislature. The Court's software vendor held numerous design meetings in preparation for upgrading the existing Court software. The online Court lookup system received updates from the software vendor affecting security and display elements. He attended the National Center for State Courts sponsored CTC9 (Court Technology Conference 9). CTC9 is an international convention showcasing the latest technology and software for court operations.

## **INTERNET SITE**

Since its debut in 1998, the Court website has been accessed over 304,000 times. In 2005, the website was accessed an average of 2,222 times per week. This is a 35% increase from 2004.

The online access that was added in late 2002 allows users to inquire about cases that have been filed in the court via the Internet. Certain items of information are not available (social security numbers, for example) due to privacy concerns. However, online users should be able to view information about any case filed since 1987. This is a popular feature, used not only by the general public, but also by attorneys, paralegals, legal secretaries, law enforcement officers, jurors, and witnesses.

In March 2005, court employees volunteered their time to distribute brochures at the Medina County Home & Flower Show. These materials explained the information that consumers, homeowners, and business owners can find through the Court's website. The response from those in attendance was very favorable.

### **FOREIGN LANGUAGE INTERPRETING SERVICES**

The Court continues to see an increase in the number of criminal and traffic cases involving defendants who do not speak English and require assistance in their native language to understand the court proceedings. The Court contracted with Language Line Services of Monterey, California to provide language translation for short court proceedings (approximately 5 to 10 minutes in length) and with Monarca Language Services, a Medina business, for all other translation services.

### **CLERK OF COURT**

Appointed by Judge Chase in December 2004, Lori A. Henry became the new Clerk of Court on January 23, 2005.

The Clerk's office employs one full-time chief deputy clerk, nine full-time deputy clerks and one part-time deputy clerk.

Monthly clerk meetings and customer service training, implemented in February, provide communication and education for the deputy clerks. Customer service training, the main focus in the Clerk's office, is an on-going program implemented to better assist the community served by the Court.

Cross training of all deputy clerks continues to be a primary objective for the office. Our goal of the Clerks' Office is to have all clerks cross-trained and knowledgeable to better serve the public, law enforcement agencies, attorneys, and the Court in all areas.
