The following is the yearly report of operations for the Medina Municipal Court as required by Ohio Revised Code Sec. 1901.14.

The Court received new filings of 16,504 cases and terminated 17,275 cases.

These cases generated \$4,862,801.90 of disbursements, which include bond and civil judgments.

PROBATION DEPARTMENT

Marirose Power, Chief Probation Officer

The probation department employs three full-time general supervision probation officers, a part-time officer supervising a specialized caseload of drug offenders, a full-time intensive supervision probation officer (ISP), a full-time chief probation officer and three part-time clerical staff. Grants from the State of Ohio Department of Rehabilitation and Correction fund the salary and benefits of the ISP officer and one member of the clerical staff. The ISP program serves both Medina and Wadsworth Municipal Courts.

The department completed 1,404 pre-sentence investigations, 77 sealing of record investigations, and reviewed over 1,000 traffic cases prior to sentencing. Of the 595 new offenders placed on probation, 50% were convicted of an O.V.I. offense, 13% of underage alcohol offenses, 11% of drug offenses, 7% for theft offenses and 6% for offenses of violence (including domestic violence). The remaining 13% represents various other criminal and traffic offenses.

The department conducted over 2,900 reporting appointments and required nearly 1,500 drug tests. Thirty-three offenders served terms of electronically-monitored house arrest, while 22 individuals completed community service assignments as a condition of probation. Sixty-four individuals were charged with violating conditions of probation.

ALCOHOL TREATMENT FUNDS AND JAIL COSTS

The Court collected \$51,742.78 for the Indigent Drivers Alcohol Treatment Act (IDATA) in 2009. These funds can be used to pay for treatment of indigent defendants. The Court also collected \$27,923.90 for Driving Under the Influence of Alcohol jail costs, which was paid to the Medina County Auditor. The Court disbursed to townships, cities, Medina County and the State of Ohio a total of \$12,452.84 from funds collected under the Driving Under the Influence of Alcohol Act. These funds may be used by the arresting agencies for equipment, training, and enforcement of driving under the influence of alcohol laws.

BAILIFF'S OFFICE

Carl Meding, Bailiff

The Bailiff's Office employs one Bailiff and four full-time Deputy Bailiffs. Bailiffs are responsible for courtroom and building security, attending to the Court's electronic recording system, and overseeing the activities of all individuals present in the building and on the grounds. The Bailiff's Office supervises seven part-time security personnel who operate the Court's metal detector and screen all persons entering the building.

In 2009, the Bailiff's office supervised 130 evictions, including 11 voluntary move-outs after Court ordered writs were issued. (See Table #1)

The Bailiff's Office maintains and operates the Court's Law Enforcement Automated Data System (LEADS) and recently received its fourth straight excellent rating during the 2009 audit cycle.

The Bailiff's Office actively pursues people who have failed to appear at Court or have otherwise ignored Court orders. During 2009, the Court's bailiffs physically arrested 106 defendants and cleared a total of 568 warrants by all means. (See Table #2) The enforcement of warrants for fines and costs resulted in payments of \$81,320.84. This warrant activity also includes the publication and distribution of the Court's Most Wanted Posters. This allows the community to assist the Court in resolving outstanding warrants. Table #3 details warrants on hand at the end of 2009.

A unique program administered by the Bailiff's Office is the entry of information on certain convicted defendants into the Federal National Crime Information Center's (NCIC) Supervised Release File. This file tracks those convicted defendants who are placed on probation. The program began in April 2006 and currently remains the only program authorized at the municipal court level in Ohio to independently enter these probationers in NCIC. At the end of 2009, the Court maintained 435 entries in NCIC.

In 2009, the Court recorded 183 contacts with other law enforcement agencies dealing with these probationers. These contacts include routine traffic citations, and other involvement in more serious matters such as OVI, felonious assault, drug trafficking, kidnapping and domestic violence.

COMPUTER DEVELOPMENTS

Rich Armstrong, Management Information Specialist

The court employs a Management Information Specialist to coordinate all technology applications. The current equipment in place consists of 41 printers and 46 PC's. A Dell 2900 server hold the court records, while another Dell 2900 server handles the online court access. A Snap Gear firewall appliance protects the internal computer systems. The court continues the conversion from Office 2000 to Office 2007 software that will continue through 2009. The Norton Antivirus was updated to Symantec Endpoint for more thorough protection of the network. New backup power supplies were installed to protect the computer systems. Upgraded network switches were purchased to increase the bandwidth available to the system. The installed value of computers and software is approximately \$500,000, of which zero dollars came from the City of Medina General Fund.

The Court transition to the new computer system and Case Management software from Civica Systems of Englewood, Ohio is continuing with the Civil application remaining to be installed. The software is continually upgraded throughout the year. The upgrade will take approximately two years to complete. New software was installed for the Criminal/Traffic Division, Probation and document scanning. Civil moved to the new operating system. Civil expects to convert to Client Server in 2010. Court records are backed up daily to an IBM Ultrium tape drive and stored off site and the Friday tapes are stored at another facility for additional safety.

The remaining administration personnel received an upgrade to the Dell Optiplex system bringing them in line with the rest of the court.

The clerical department continued to receive upgrades to their computers with new Dell Optiplex systems. The existing HP printers are being converted to copy/scan devices to enhance efficiency. These are being connected to the new scanning system installed in 2007 as the computers are updated. The older scanners were replaced with new models enhancing speed and clarity. Major software upgrades due to new Ohio legislation were implemented during the year.

The probation department is scanning new cases as they are received as well as continuing to scan historical records into the imaging database. The imaging database allows documents to be stored in digital format and printed on demand. This increases the efficiency of the department, prevents misplaced files, saves the probation officer time in retrieving the files, and reduces the physical space required for storing the files. The existing printers were updated to allow on-demand scanning of current records and an older printer was replaced with a new model to increase speed and clarity.

The website is now hosted by Blue Domino and continues to be maintained by Uplink/MSS of Medina and Civica/CMI of Englewood. The court is continuing the effort to make the website easy to use and useful to our clients.

The IT specialist attended various meetings throughout the year concerning the new laws enacted by the Ohio Legislature. The software vendor held numerous design meetings in preparation for upgrading the existing Court software. The online court lookup system received updates from the software vendor affecting security and display elements. The IT specialist attended the Court Technology Conference in 2009 with the primary focus on courtroom audio/video systems and imaging redaction technologies. Case management and web site technologies were also studied for ideas to upgrade our existing systems.

FOREIGN LANGUAGE INTERPRETING SERVICES

The Court continues to see an increase in the number of criminal and traffic cases involving defendants who do not speak English and require assistance in their native language to understand the court proceedings. The Court contracted with Language Line Services of Monterey, California to provide language translation for short court proceedings (approximately 5 to 10 minutes in length) and with Monarca Language Services, a Medina business, for all other translation services.

WEDDINGS

The Judge performed 59 weddings in 2009.
