Our MISSION:

To implement the court's objectives in promoting community safety through a system of graduated sanctions that balance service to the victim, defendant, and community. Through accurate assessment of risk and need, to inform the court's determinations concerning the extent of intervention necessary to effect positive change of those under the Court's jurisdiction.

Our VISION:

- To respond promptly and professionally to the needs of all court staff for input drawing on the department's specialized areas of training and experience
- To provide dynamic leadership in the community as we design and implement innovative, efficient, fiscally sound programs that are models of success in the criminal justice community
- To recruit and retain well trained staff who demonstrate the highest professional standards as they strive for excellence
- To promote effective interagency and collaborative partnerships that demonstrate the best practices in community based supervision
- To use leading edge technology and service delivery systems

SUPERVISION STATISTICS

On January 1, 2023, the department's adult probation population was 220 individuals under court-ordered supervision. A total of 197 individuals were discharged from probation in 2023, 92% of whom were considered successful releases.

During 2023, the court referred 226 offenders to the Probation Department for placement on supervision and community service orders. Of these, 55% were convicted of OVI or closely related offenses; 5% were convicted of domestic violence/threatening domestic violence; 5% were convicted of property offenses; 12% were other violent offenses (assault); and the remaining 22% were convicted of various offenses including but not limited to drug law violations, sex offenses, and other traffic offenses.

Reporting appointments for the year totaled 1750 total contacts and over 974 drug and alcohol screens were submitted. The Probation Department also supervised individuals ordered to pre-trial bond reporting and electronically monitored house arrest and transdermal alcohol monitoring.

In 2023, the Probation Department completed 631 Pre-Sentence Investigations (PSI) for the court including 125 involving defendants incarcerated in the Medina County Jail. A Pre-Sentence

Investigation is a report prepared by a Court's Probation Officer on request of the court. It is the report of the investigation conducted to verify the defendant's history including but not limited to the educational, criminal, family, and social background of a person convicted of a crime. It summarizes for a court the background information needed to determine the appropriate sentence.

RECORD SEALING AND EXPUNGEMENT

During 2023, the Probation Department completed 125 Sealing of Records investigations for applicants seeking that relief. As of April 2023, Senate Bill 288 amended Ohio Revised Code sections 2953.32 through 2953.34 to allow certain criminal convictions to be "expunged." "Sealing" and "Expungement" produce different results. An "expunged" record is physically destroyed. A "sealed" record is one that knowledge of its existence is legally prevented, and to which public access is strictly limited except for purposes specified by statute. The court may also "unseal" sealed records for specified statutory purposes.

VICTIM IMPACT STATEMENTS

During 2023, the Probation Department processed 162 victim impact statements. Victim impact statements are written or oral information from crime victims, in their own words, about how a crime has affected them. Courts must consider victim input in decision making about, e.g., sentencing, plea agreements, probation revocations, and in the determination of restitution owed to the victim for harms to the victim caused by the crime.

MONITORING AND COMMUNITY SERVICE

In 2023, the Probation Department monitored 69 clients on Continuous Alcohol Monitoring (CAM) devices for a total of 4,789 days of monitoring. There were 4 confirmed alcohol consumption violations and 24 instances of tampering with the monitoring equipment. The MMC Probation Department reached a 99.5% "sober days" rating, which means that of the 4,789 days clients were monitored, 99.5% of them were quantifiably abstinent. Nationally, in 2022, the average was 99.0%. Clients in the CAM Program participated for an average of 100 days.

In 2023, 6 MMC clients were monitored with Global Positioning (GPS) for a total of 328 days.

During 2023, 3,000 Hours of Community Service Work (CSW) were completed on projects benefitting the citizens of this jurisdiction. The services these projects represent reflect a savings of approximately \$30,000.00 to local taxpayers. The three most utilized agencies for CSW were:

- 1. City of Medina Public Works/Service Department
- **2.** Goodwill
- **3.** Salvation Army

VETERANS TREATMENT COURT

In 2021, Judge Werner established the State of Ohio's 29th Veterans Treatment Court Program, otherwise known as Valor Court. Final certification was granted by the Supreme Court of Ohio on 12/26/21 for three (3) years of operation. The Valor Court Program is currently applying for re-certification in 2024 seeking three (3) additional years of operation as a Certified Specialized Docket.



Veteran's Treatment Courts are specialized dockets dedicated to defendants with military experience who find themselves in the criminal justice system. It was established recognizing that

many of our veterans return to civilian life with serious physical, substance abuse disorders, and/or mental trauma. Too often, these conditions lead to their involvement with the criminal justice system. Valor Court provides an evidenced-based alternative to traditional sentencing methods. It uses a non-adversarial approach to addressing criminal offenses and is structured to assist the veteran with access to programs, treatment, and interaction with mentors to promote sustained success.

To date: Twenty-Eight (28) individuals have elected to participate in Valor Court since program inception. Fifteen (15) Vets completed their placements and period of supervision earning successful releases. Valor Court received grant funding (\$150,000.00) from the Ohio Department of Mental Health & Addiction Services (OMHAS) to be used for the operation of the Valor Court Program through fiscal year 2025. The Valor Court Program also received an ATP (Addiction Treatment Programming) Grant in the amount \$31,050.00 from the Medina County Alcohol, Drug Addiction & Mental Health Board and Ohio Department of Mental Health and Addiction Services Department (OMHAS) to expand and offer resources to veterans who are otherwise not eligible to receive Department of Veterans Affairs benefits.

GOALS

The Probation Department's goals for 2024 include: expanding Valor Court access to assist more justice involved veterans; increasing success rates of individuals placed on probation; and working with local treatment providers to increase access to support systems and substance abuse treatment programming, including medication assisted therapy (MAT).

OFFICE FUNCTIONS

Bailiffs have primary responsibility for ensuring courtroom and general building security. They also operate the Court's audio recording system; assist, document, and process in-court proceedings using the court's Benchmark Case Management System; and assist the Court's Probation Department by conducting field visits. The Chief Bailiff also supervises three additional part-time security guards who operate the Court's metal detector at the Court's security checkpoint.

SERVICE AND ENFORCEMENT OF ORDERS

During 2023, the Bailiff's Office scheduled and executed 105 Writs of Execution (eviction orders) (see Table #1) and zero (0) Replevin actions; and conducted two (2) Court ordered auctions. One

Deputy Bailiff is responsible for the service of subpoenas and other court documents throughout the Court's jurisdiction. This includes executing evictions and Court ordered recovery/sales of property.

The Bailiff's Office continues to pursue and apprehend defendants who have failed to appear in Court, or otherwise ignored court orders. The Bailiff's Office cleared a total of 780 warrants by all means in 2023. This compares to the 234 total warrants cleared in 2022 by the Bailiff's Office. Staffing levels and other contributing factors reduced the Office's involvement in serving warrants during 2023.

PRETRIAL AND POST-SENTENCING MONITORING

The Bailiff's Office is responsible for entering defendant information into the NCIC/LEADS Supervised Release File data base. Law enforcement then may access this information when subsequent contact is made with these defendants and may ascertain their status with the Court. The Bailiff's Office manages this data for defendants that are not in custody but are being monitored by the Court on pretrial release (e.g., as a condition of their bond) and for convicted defendants who are on probation with the Court. This remains an important Bailiff's Office function.

Monitored pretrial release allows the Court to maintain some pre-adjudication control over low-risk defendants and to assist the county jail in reducing the jail population, which is always a priority. Law enforcement contacts with probationers are reported to the Court's Probation Department. This enhances the Department's probationer monitoring and provides additional important information (e.g. individuals being screened by ICE, or individuals being screened for a firearm purchase).

During 2023, the Bailiff's Office entered into the Supervised Release File 163 defendants on pretrial release (79 defendants were already active in that data base at the beginning of 2023). The subsequent contacts with law enforcement agencies that these produced were investigated by the Bailiff's Office. Potential bond violations are referred to the Magistrate for a hearing.

At the end of 2023, 191 Court probationers were listed in the Supervised Release File. The notifications ("hits") the Court received from law enforcement during 2023 concerning probationer contacts were forwarded to the Probation Department. These contacts ranged from minor traffic violations, to more serious misdemeanor offences such as OVI, DOMESTIC VIOLENCE and VIOLATING PROTECTION ORDERS, as well as felony violations including FELONIOUS ASSAULT, AGGRAVATED DRUG POSSESSION and VANDALISM. The Probation Department evaluates these contacts for potential probation violations.

Furthermore, the Bailiff's Office also partners with Probation Officers when requested to assist in conducting home visits to probationers. These visits are performed in an effort to monitor the probationer and insure compliance with their conditions of probation.

SECURITY INCIDENTS

In regards to the court security function, the Bailiff's Office handled six (6) extraordinary incidents in the Court. A synopsis of these incidents is listed below.

2023 SECURITY INCIDENT SYNOPIS

1/12/2023

Threats made via telephone toward a specific Probation Officer and other court staff. Medina PD was advised and a report was taken.

3/22/2023

Defendant in court for privileges. When advised that his privileges were no longer valid due to them being expired for a length of time he stated that he was going to Uber home. A Deputy Bailiff observed Defendant drive away, which was addressed at hearing that was set.

5/3/2023

Defendant showed for Jury trial intoxicated. Medina PD was advised and investigated.

9/11/2023

Deputy Bailiff serving eviction. Male resident refused to exit home and began barricading the door with household items. Medina PD was advised and assisted in removing male without further incident.

9/12/2023

Female giving the clerk's office a hard time in reference to how they procedurally conduct business. She was witnessed by numerous staff members, along with other patrons of the court. Chief Bailiff approached and inquired as to what the issues were she began to yell and not wanting to have a conversation. Ultimately she was advised that if her business with the court was finished she could leave the premises. Upon walking outside she approached the Court Manager and another bailiff. She spoke with the Court Manager stating that she wished to file a complaint against the Chief Bailiff. The Court Manager determined what occurred, informed the female that the situation was handled correctly, and advised that she could leave.

10/12/2023

While an officer from Montville PD was present in the Clerk's office, a defendant who was in the lobby began to yell at the officer and make statements in a threatening tone. The male was advised by numerous court employees to calm down and conduct the business he was present at the court for. The male kept referring to the officer, saying "he and I have a history". The male completed his business with the Clerk's office and exited the building. Once the officer was ready to leave, Chief Bailiff escorted him outside where the male was seen re-entering the parking lot after already leaving, just to make visual contact with the officer.

IT DEVELOPMENT 2023 Annual Report

Joshua Strong Senior IT Technician

The IT (Information Technology) Department played a pivotal role in advancing Medina Municipal Court's strategic goals in 2023. This report highlights key achievements, projects challenges, and outlines the department's plans. The IT Department remains committed to driving technological innovation, enhancing operational efficiency, and supporting and Court's overall success.

INFRASTRUCTURE MODERNIZATION

The Department completed infrastructure upgrades, improving system reliability and performance.

CYBERSECURITY

The Department worked closely with Medina City to implement new enhanced cybersecurity measures to safeguard sensitive data and emails. The Department secured for the court's domain an Extended Validation SSL certificate, which involves a full background check of the organization. The Certificate Authority will make sure that the organization exists and is legally registered as a business, that they actually are present at the address they list, and so on. This validation level takes the longest and costs the most, but Extended Validation SSL certificates are more trustworthy than other types of SSL certificates.

EQUIPMENT

The courts equipment in place consists of 7 desktop printers, 6 Multi-Function centralized printers (3 with VoIP fax lines), 49 desktop workstations, and 3 laptops. The court currently employs Scale Computing servers. These servers handle the case management system, segmented network storage, and online court access. A Meraki firewall appliance is installed to comply with requirements from the Ohio Leads Organization. For virus protection the court has Trend Micro running on all systems. Three Meraki access points are installed to allow employee and visitor access to the internet.

The court continues to work with Technology Engineering Group for guidance in hardware and software programs. They continue to be a highly valued asset to the courthouse for high level troubleshooting, maintenance, and implementation.

The court utilizes a case management system called Benchmark by Pioneer Technology Group of Sanford, Florida. The IT admin is heavily involved in the continued improvement and operation of the Benchmark software. The courthouse is working very closely with Pioneer and is testing benchmarks implementation for text notifications. Text notifications will provide more convenience for the public providing them with mobile reminders for scheduled appearances, payments due, etc. These notifications should also decrease the number of defendants that fail to appear.

Audio is recorded in both courtrooms by software from FTR systems and is stored on the network drives. Archive audio dates to 2003 and is also backed up using Intronis backup system and stored locally. Post COVID the courthouse has continued the use of remote video hearings for things like Valor Court, arraignments, and for individuals in custody, using our Poly x50 video conferencing systems.

There are two Law Enforcement Automated Data System ("LEADS") systems in use by the court allowing authorized users to look up data for court processing. This also reduces the workload for Medina Police Department. The system is secured by a Meraki firewall and air gapped from our normal production network.

Blue Domino currently hosts the website, but we may revisit hosting options over the coming year.

The court camera system is managed on premise via a Paramount DVR. This year we updated two old/failed cameras, the total number of cameras is 20 (10 IP cameras and 10 analog cameras).

KEY ACHIEVEMENTS

This year the courthouse successfully removed all individual clerk printers fully utilizing centralized printing. This change has proven to save the courthouse a significant amount of funds, as we are not buying many individual toners/drums each month.

After a long year of working closely with WRIS the court has gone live with our new website redesign. This gives the public a much cleaner and easier portal to navigate, receive news announcements from the court, interact with the court, look up case information, or find and access our forms and resources. The site supports the functionality to allow lookups based on case scheduling for criminal, traffic, and civil cases.

TRAINING/DEVELOPMENT

In April, I attended The Ohio Judicial College (OJC) Court Tech Conference in Columbus. The educational topics are relevant to many aspects of technology in the court system. The focus of the conference was on leadership through technological advancements and changes that must last over time to improve court services and access to justice.

I currently participate on the Emerging Technology Committee, the members of which include Medina City Councilman, Paul Rose; Medina City Police Department, Sgt. D. Zaremba; General Manager of Medina TV, Jarrod Frye; Medina City residents; and others.

In September 2023, I was given the opportunity to attend the OPOTA (The Ohio Peace Officer Training Academy). Throughout the rigorous training program, I had the privilege of learning from seasoned professionals and dedicated instructors who are committed to shaping individuals into competent and ethical peace officers. The comprehensive curriculum covered a range of critical topics, including criminal law, use of force, crisis intervention, and community policing. The training consisted of 6 days and 40 hours of intense classroom and range qualifications. I successfully completed the OPOTA Program with perfect marksmanship score. Upon my graduation, I was sworn in by Judge Werner as a Deputy Bailiff/Senior IT Technician for the court.

FOREIGN LANGUAGE INTERPRETING SERVICES

The Court maintains interpreting services for defendants who do not speak English and require assistance in their native language to understand court proceedings. The Supreme Court of Ohio contracts with Language Line Services of Monterey, California and offers their services to Ohio Courts to provide language translation for short court proceedings (approximately 5 to 10 minutes in length). Monarca Language Services, a Medina business, is used by the Court for other translation services.

WEDDINGS

Judge Werner performed 32 weddings in 2023.
